Lot 1:

- 1. Thus, the value "5 cm" is taken as a basis. Therefore, the pay item under code 50401 in the 3rd line of BOQ section "5. Base" of should be read as «Բիտումով մշակված մանրահատիկ խմավազային խատնուրդով հիմքի շերտ h=5uմ / Bitumen treated fine graded crushed sand mixture base course h=5cm»,
- 2. According to design drawings and summaries, the works «Բետոնե եզրաշարերի կառուցում 10x20uմ (Construction of concrete shoulder support 10x20cm)» are envisaged to be implemented with in-situ concrete. Thus, the value "in-situ" is taken as a basis. Therefore, the pay item under code 90703 in the 6th line of BOQ section "9. Road furniture" should be read as «Բետոնե եզրաշարերի կառուցում 10x20uմ / Construction of concrete shoulder support 10x20cm»:

Lot 2:

- 1. Thus, the unit "each" is taken as a basis. Therefore, the unit of measure for pay items under code 90601 in lines 5 and 6 of BOQ section "9. Road furniture" should be read as "each".
