- The Republic of Armenia has received a loan from the Asian Development Bank (ADB) towards the cost of: North-South Road Corridor Investment Program. Part of this loan will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB as per Section 5 of the Bid Document.
- The Ministry of Territorial Administration and Infrastructure of the Republic of Armenia ("the Employer") invites sealed bids from eligible bidders for the construction and the completion of the project: CW-ICB-T2-2021/1- Reconstruction of about 8.0 km of highway M1 Yerevan-Gyumri-Bavra, near Agarak community (from km 29+600 to km37+545) ("the Works").

The Works involves the construction of approximately 8 km of dual 2 lane carriageway on greenfield site with asphalt pavement.

The Works will include approximately 750,000 m³ and 440,000 m³ of common/rock excavation respectively and 825,000m³ of embankment fill.

All Works must be undertaken in accordance with ADB Safeguards Policy Statement (SPS)

Between km32+700 and 33+400 the alignment crosses a Historical and Archeological reserve on an embankment of up to 5m height.

The Contractor shall carry out the Works in accordance with the detailed design and the requirements of the technical specifications, which are part of the Bidding Document to be provided by the Employer.

- 3. International Competitive Bidding will be conducted in accordance with ADB's <u>Single Stage Two-Envelope without prequalification</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following and other key qualifications **mentioned in the Section**3 and Section 6 of the Bidding Documents should participate in this bidding:
 - Pending Litigation: All pending litigation and arbitration, if any, shall be treated as resolved against the Bidder and so shall in total not represent more than 50 (fifty) percent of the Bidder's net worth calculated as the difference between total assets and total liabilities.
 - Financial Situation: As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive. Minimum average annual construction turnover of USD 25,200,000 (twenty-five million two hundred thousand) calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years. Bidder must demonstrate that its financial resources meet or exceed the total requirement for the Subject Contract of US\$ 5,000,000.
 - Construction Experience: Participation in at least one contract that has been successfully or substantially completed within the last 10 (ten) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 20,160,000 (twenty million one hundred sixty thousand), or at least two contracts that have been successfully or substantially completed within the last 10 (ten) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 10 080 000 (ten million eighty thousand).
