

**NOTICE  
ON OPEN TENDER**

This text of the notice is approved by decision of the Open Tender Commission № 2 of 21<sup>th</sup> May of 2018 and is published pursuant to Article 27 of the Law of the Republic of Armenia "On procurement" Code of the open tender AF-OTPG-18/1

The contracting authority "Hayantar" SNCO, located at the following address: Yerevan, 129 Armenakyan str. invites notice for an open tender which shall be carried out in one stage.

The bidder selected based on the results of the open tender will be proposed, in a prescribed manner, to conclude a contract for supply of cars (hereinafter referred to as "the contract").

Pursuant to Article 7 of the Law of the Republic of Armenia "On procurement", any person, irrespective of the fact of being a foreign natural person, an organisation or a stateless person, shall have equal right to participate in this tender.

The qualification criteria for the persons ineligible to participate in the tender, as well as for bidders, and the documents to be submitted for evaluation of those criteria shall be established by the invitation for this procedure.

The selected bidder shall be determined from among the bidders having submitted bids evaluated as satisfying the requirements of the invitation, by the principle of giving preference to the bidder having submitted the lowest price proposal.

For receiving the hard copy of the invitation to tender, it is necessary to apply to the contracting authority by 12:00 o'clock of the 14<sup>th</sup> day from the date of publication of this notice. Moreover, an application in writing must be submitted to the contracting authority for receiving the hard copy of the invitation. The contracting authority shall ensure the free of charge provision of the hard copy of the invitation on the first working day following the receipt of such request. In case of a request to provide the invitation electronically, the contracting authority shall ensure the free of charge provision of the invitation electronically within the working day following the date of receipt of the application.

Failure to receive the invitation shall not limit the bidder's right to participate in this procedure.

The bids for the tender must be submitted to the following address: Yerevan, 129 Armenakyan str., in hard copy, by 12:00 o'clock of the 15<sup>th</sup> day from the date of publication of this notice. The bids may, in addition to Armenian, also be submitted in English or Russian.

The bid opening will take place at the following address: Yerevan, 129 Armenakyan str., on 12:00 o'clock of the 15<sup>th</sup> day from the date of publication of this notice.

The appeals concerning this procedure must be filed to the Procurement Appeals Board, to the following address: Melik-Adamyan St. 1., Yerevan. The appealing shall be carried out as prescribed by this invitation to tender. For filing the appeal, a fee shall be required in the amount of AMD 30 000 (thirty thousand), which must be transferred to the treasury account 900008000482 opened in the name of the Ministry of Finance of the Republic of Armenia.
