

**NOTICE
ON PRICE QUOTATION**

The text of the following announcement is approved by the price quotation enquiry committee decision N 1, dated 20 september, 2018 and is being published according to article 27 of the Law of the Republic of Armenia "On Procurements".

The code of the price quotation enquiry procedure: «SNP-PQAS-18/09»

Procuring entity: " Sevan" national park" SNCO of ministry of nature protection of Republic of Armenia, (address: Gegharkunik region, Sevan, Karmir Banak 56) announces a price quotation enquiry procedure, which is being realized by one stage.

The participant chosen for a price quotation enquiry will be suggested to sign a contract on Professional Laboratory Research Services (hereafter contract).

According to the article 7 of the Law of the Republic of Armenia "On Procurements", any person or entities, irrespective of being a foreigner, a foreign entity or a stateless person, has equal rights to participate in the price quotation enquiry procedure.

The qualifying criteria and documents for assessing these criteria for persons, who do not have the right to participate in the tender, as well as for the participants, are established by the invitation of this procedure.

The winning participant is determined from the participant's submitted responsive evaluated bids. The preference will be given to the participant who submitted financial proposal in minimal price.

In order to receive the invitation of this procedure in a hard copy it is required to apply to the Procuring entity till 12:00 of the 6th day, calculated from the following day of the announcement publication. Moreover, to receive an invitation in a hard copy it is necessary to send a written request to the Procuring entity. The Procuring entity is obliged to provide the hard copy for free within the following working day upon receiving such a request.

In case of getting a request for providing the invitation electronically, the Procuring entity shall ensure provision of invitation via electronic email within a working day following the day of getting such a request.

Failure to receive the invitation as prescribed by this invitation shall not restrict the right of the participant to participate in this procedure.

The bids for the price quotation enquiry procedure should be submitted to the address Gegharkunik region, Sevan, Karmir Banak 56, in a hard copy and the deadline is till 12:00 of the 7th day calculated from the following day of the announcement publication. The bids, besides Armenian, may also be submitted in Russian or English.

The opening of the bids will take place at the address Gegharkunik region, Sevan, Karmir Banak 56 at 12:00 of the 7th day calculated from the day of the announcement publication.

The complaints regarding the open procedure are to be submitted to Procurement Appeals Board, at the following address: 1 Melik-Adamyanyan, Yerevan. The appeal is conducted by the order defined by the given price quotation enquiry invitation. To submit an appeal it is required to pay a fee, equal to AMD 30 000 (thirty thousand), which has to be transferred to the following treasury account of the Ministry of Finance, RA: 900008000482.

This procurement process is organized on the basis of the 6th part of 15th article of the law on Procurements of RoA.
