Scope of Contract: **The consulting services (“the Services”) comprise technical supervision and quality control over construction/rehabilitation of on-farm irrigation systems (tertiary canals) in 105 communities of Ararat, Armavir, Kotayk, Aragatsotn, Gegharkunik and Syunik Marzes (Provinces). The extremely emergency and emergency sections of the on-farm irrigation networks with the total length of 259.3km located within the service areas of 27 Water Users Associations (WUAs) will be rehabilitated/ reconstructed. The rehabilitation/construction of on-farm irrigation systems will be implemented through 3 construction packages. The duration of each package is 17 calendar months including vegetation period.**

Notes:

“Toossab Consulting Engineering Co.”: total Amount of Financial Proposal (Form FIN-1) is USD 1,766,363.00 (including of all indirect local taxes, which is calculated by the Consultant USD 52,991). As per Form FIN-2 (“Summary of Costs”) in section “Indirect Local Tax Estimates – to be discussed and finalized at the negotiations if the Contract is awarded” line item (i) “VAT under client liabilities – 20%” was not reflected in figures, except for amount USD 52,991 under line item “(ii) income tax under consultant liabilities”. The Evaluation Committee recalculated the indirect local tax (i.e. only VAT 16.67%, which is USD 294,393.83) and compare the adjusted amount (which is USD 1,471,969.17) with other Proposals.

“Farazab Consulting Engineers”: the arithmetical errors (+ USD 57,344.00) were found in the Form FIN-3 (Breakdown of Remuneration) of each Packages – there were a discrepancy between the amount derived by multiplication of unit price with quantity and the total price. The total price is corrected accordingly as per ITC sub-clause 24.1.1 of RFP.

The date of exchange rates is the day of proposals submission i.e. May 6, 2020 (1USD= 481.97AMD; 1EUR=519.80AMD). The source of official selling rates is the Central Bank of Armenia (www.cba.am)
