The Ministry of Territorial Administration and Infrastructure of the Republic of Armenia ("the Employer") invites sealed bids from eligible bidders for the construction and the completion of the project: CW-ICB-T2-2022/2 Completion of construction of about 34.0 km of highway M1 Yerevan-Gyumri-Bavra (from km 37+545 to km 71+435) ("the Works").

The Works involves the completion of construction of approximately 34 km of dual 2 lane carriageway with asphalt pavement, associated structures and interchanges.

The Works include approximately 820,000 m³ of excavation (of which 373 000 m³ is in rock) and 636,000 m³ of embankment fill.

All Works must be undertaken in accordance with ADB Safeguards Policy Statement (SPS)

The Contractor shall carry out the Works in accordance with the detailed design and the requirements of the technical specifications, which are part of the Bidding Document to be provided by the Employer.

- 3. International Competitive Bidding will be conducted in accordance with ADB's <u>Single-Stage: Two-Envelope</u> procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following and other key qualifications mentioned in the Section 3 and Section 6 of the Bidding Documents should participate in this bidding:
 - Pending Litigation: All pending litigation and arbitration, if any, shall be treated as resolved against the Bidder and so shall in total not represent more than 50 percent of the Bidder's net worth calculated as the difference between total assets and total liabilities.
 - Financial Situation: As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive. Minimum average annual construction turnover of USD 60,000,000 calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years. Bidder must demonstrate that its financial resources meet or exceed the total requirement for the Subject Contract of USD 10,000,000.
 - Construction Experience: Participation in at least one contract that has been successfully or substantially completed within the last 10 (ten) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 48,000,000.
