This ADDENDUM is issued on April 10, 2026, in connection with Request for Proposals (RFP) No. PSMP4-GO-RFP-1.2.2/1-2, issued on March 24, 2026, for the Procurement of the e-Penitentiary System under the Fourth Public Sector Modernization Project (PSMP4).

NOW THEREFORE, the Request for Proposals (RFP) No. PSMP4-GO-RFP-1.2.2/1-2 is hereby amended as follows:

**1. Amendment to Section II – Proposal Data Sheet (PDS) of the RFP is as follows:**

- (i) In ITP Clause 19.1, the words: *“The Proposal shall be valid until: August 19, 2026”* are hereby amended to read as follows:

“The Proposal shall be valid until: August 28, 2026.”

- (ii) In ITP Clause 20.1, the words: *“The date for the exchange rate for the Proposal Security shall be: April 14, 2026”* are hereby amended to read as follows:

“The date for the exchange rate for the Proposal Security shall be: April 23, 2026.”

- (iii) In ITP Clause 20.3, the words: *“The Proposal Security shall be valid until: September 16, 2026”* are hereby amended to read as follows:

“The Proposal Security shall be valid until: September 25, 2026.”

- (iv) In ITP Clause 23.1, the words: *“The deadline for Proposal submission is: Date: April 21, 2026, Time: 15:00 (local time)”* are hereby amended to read as follows:

“The deadline for Proposal submission is: Date: April 30, 2026, Time: 15:00 (local time).”

- (v) In ITP Clause 26.1, the date for Proposal opening is hereby amended as follows:

“Date: April 30, 2026, Time: 15:00 (local time).”

All other provisions of ITP Clause 26.1 shall remain unchanged.

- (vi) In ITP Clause 36.2, the date for the exchange rate to be used for Proposal evaluation is hereby amended as follows:

“Date: April 30, 2026”

All other provisions of ITP Clause 36.2 shall remain unchanged.

**2. All other provisions of the request for proposals (RFP) shall remain unchanged.**
